The second round of the 2018 Lotus Club Qld Lakeside DTC Timed Laps event is on Sunday 29th April 2018 at Lakeside Raceway Driver Training Centre Lakeside Road, Kurwongbah Qld.

This event is very popular, so please send your entries in early, so you do not miss out.

The Lakeside Driver Training Centre is at the rear of Lakeside Raceway main track and has a combination of layouts – see map below.



The Timed Lap event format is a single car run for a single timed lap.

This will be an all-day event starting at 7.30am for registration and scrutineering, please arrive early as scrutineering can take some time.

Entry Fee is \$100.00 per driver.

You must register and pay before the day, as NO entries will be accepted on the day.

CTP Rally Extension letter.

If your vehicle is currently Queensland registered you will need to apply for a Compulsory Third Party (CTP) insurance Rally Extension letter from your CTP Insurer – see sample attached.

If you're Third Party (CTP) Insurer is Suncorp Ltd, Allianz Australia Insurance Ltd or AAI Ltd you can apply on-line using his email address; - Insurance.CustomerCTP@suncorp.com.au

RACERS Licence and Forms.

This event is run under RACERS Recreation and Competitive Events Resources and Services Licence and Insurance arrangements.

Note: The Lotus Club Qld is not able to accept RACERS Day Licence applications and/or RACERS Annual Clubman licence renewal payments.

To obtain your RACERS Day Licence or renew your RACERS Annual Clubman Licence please apply on-line through the RACERS website at - <https://racers.world/login> and complete your application and licence payment.

Please also complete and bring on the day the completed RACERS InfoPak forms ie: Liability Release Waiver, Crew Member Release (if applicable) and the Car & Equipment Checklist – see attached.

On the day you MUST bring your following signed original forms;

- 1) **Signed original Queensland Raceways Entry form.**
- 2) **RACERS Annual Clubman licence – if applicable**
- 3) **RACERS Day Licence confirmation email – if applicable.**
- 4) **RACERS DTC InfoPak 2018 – Waiver, Crew and Scrutineering forms.**
- 5) **CTP Rally Extension letter – if applicable.**
- 6) **Civil Drivers Licence.**
- 7) **Car Club membership card – if applicable.**

Note: It is essential you bring these original signed forms on the day as they will be required by the QR Lakeside staff when you register.

Other Information,

CAMS/AS approved helmet in good condition must be presented at scrutineering and must be worn while competing. A full face helmet visor is required if you are driving an open car.

Neck to ankles and wrists to neck clothes and closed footwear is required.
Fire suits are not required but their use is encouraged.

Seat belts must be in good order; standard fitted lap-sash belts are accepted.

Noise restrictions apply at Lakeside = 92db measured from a position 0.5m behind the exhaust at a 45 degree angle, with the engine running at $\frac{3}{4}$ maximum revs.

Dorian transmitters are not used for this event.

Fire Extinguishers are not required but fitting of them is encouraged.

Note: Entry closing, credits/refunds, and vehicle retrieval/transfer details on the attached Queensland raceways "Conditions of Entry" forms are NOT APPLICABLE to this event.
